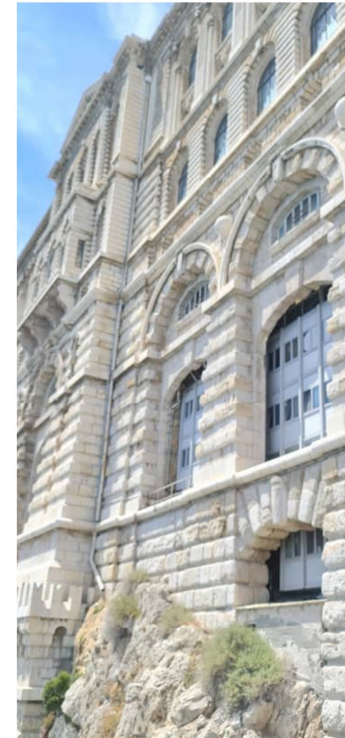


WHY MONACO - 200 CONCENTRATION OF MULTIPLE MILLIONAIRES AND GENERATIONAL WEALTH CREATORS

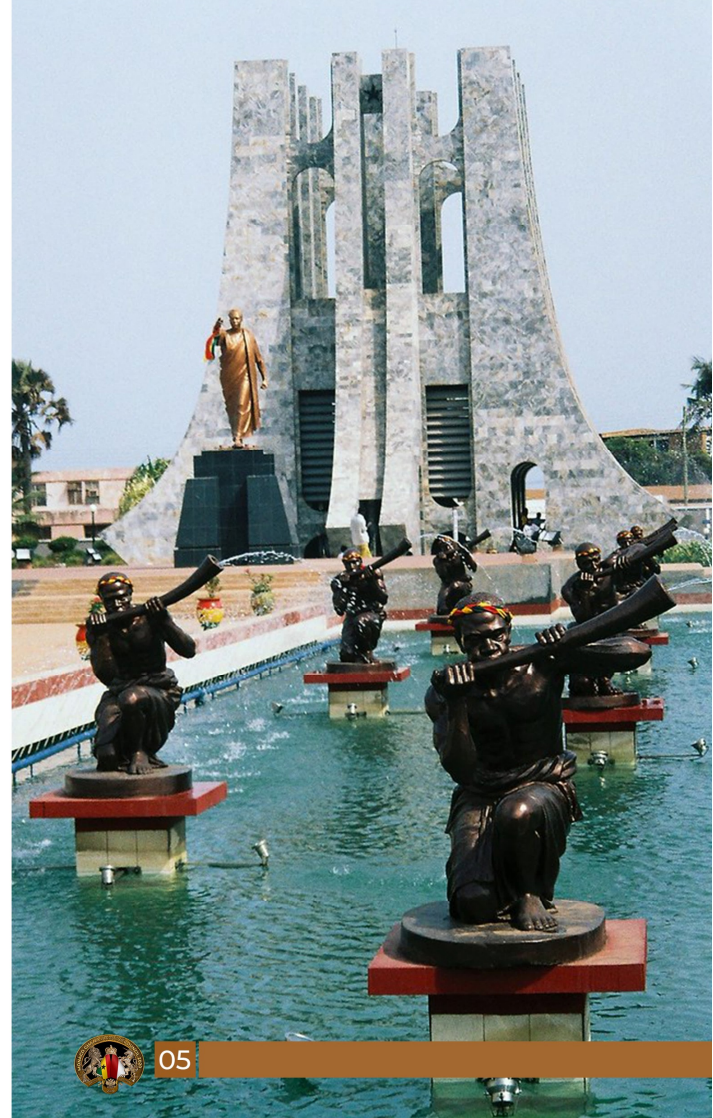
